RULES OF GOOD BEHAVIOR

Nature Essentielle reserves the right to refuse to take care of a child if his/her behavior is incompatible with the activities of the day or if he/she behaves in an anti-social manner. No refunds will be given.

Families are required to pick up and drop off their children at the agreed time, except in cases of force majeure. In case of force majeure, parents must inform Nature Essentielle of their lateness. In case of repeated lateness of the parents, the children may be temporarily excluded. The children will be handed over directly to the parents or to the persons designated by them in writing. No refunds will be given.

GENERAL CONDITIONS OF SALE

The general terms and conditions of sale apply to all bookings made with Nature Essentielle.

Prices: All requests are subject to an offer. A reservation becomes firm upon receipt of a confirmation of the estimate and a deposit.

Invoicing: A pro forma invoice will be sent to the client upon receipt of the acceptance of the offer and the terms of payment. The final invoice will be sent the day after the event and will include any add-ons ordered during the event.

Terms of payment:

For all services (except children's courses & stays), 30% of the total amount is payable to NATURE ESSENTIELLE at the time of reservation, and the balance on the day of the service, unless otherwise agreed. Any additional services mentioned on the final invoice must also be paid on the day of the service.

For Kids Courses & Stays, 30% of the total amount must be paid to NATURE ESSENTIELLE at the time of booking and the balance 1 month before the start of the course, unless otherwise agreed. Any additional orders mentioned on the final invoice will be paid on the day of the course.

Cancellation conditions for the client:

- More than one month before the event: full refund by check of the deposit paid at the time of booking.
- Between one month and 15 days prior to the event: 100% of the deposit paid will be charged to the client.
- Less than 15 days prior to the event: 70% of the event will be charged to the client.
- Less than 7 days prior to the event: Nature Essentielle will invoice the client for the full amount of the event.
